FAQs

Q: How long does it take to receive a physical study book?

A: Approximately 3-4 weeks from the time registration closes (Training Bundle subscribers do not get a physical study book. They will use the PDF version only.)

Q: What if I am not able to complete the FiCEP program?

A: Student understands that barring extraordinary circumstances, they will complete the full program in the provided time frame. If not completed with the scheduled timeframe, the fees will not be reimbursed, and program participation will be forfeited.

Q: How much study time do I allot for each chapter prior to each exam?

A: Unfortunately, there is no specific answer to this. Everyone learns at a different level, reads at a different pace, and learns in different environments. Following the recommended study schedule will help you stay on track.

Q: What if I do not have a webcam to take the virtual proctored exam?

A: You may use a cell phone to log into the zoom session to use video and audio from your phone while you test from your computer. The phone will need to be fully charged, silent, and be propped up in a way that the proctor can view you and your testing environment.

Q: What are my options if I am not able to test during the scheduled virtual options?

Q: If I am unsuccessful at passing the FiCEP certification test the first time, how long do I have to re-take? Is there a cost associated with re-taking the exam?

A: It is recommended that a student reschedule a testing date at least four weeks out. Students will have to pay \$50 for each exam re-take attempt, and student must submit a proctored exam request form. Cornerstone Foundation will offer one exam retake option for proctored testing (date/time to be determined after the initial testing week), or the student can retest through America's Credit Unions ProctorU.
