### **Eligibility & Instructions for Submission**

This scholarship will cover registration and travel up to \$1,500 to attend the Cornerstone Foundation's 2025 Principles & Philosophy Workshop. Only one scholarship will be awarded annually. The applicant must be an employee or volunteer of an Arkansas, Kansas, Missouri, Oklahoma, or Texas affiliated credit union.

- 1. Complete the scholarship application. Incomplete applications will **NOT** be accepted.
- 2. President/CEO of the credit union or the Board Chair must co-sign the scholarship application.
- 3. Email your completed grant application no later than May 30, 2025:

4. Foundation's program director will confirm receipt of your grant application. If you do not receive confirmation within 48 hours of submission, please contact the program director to ensure your application was received.

#### **Process**

- 1. The Cornerstone Foundation Grants Committee will review all scholarship applications and select one recipient.
- 2. Application selection will be notified by June 13, 2025.
- 3. The recipient must register to attend the 2025 Principles & Philosophy Workshop.
- 4. Scholarship funds will be disbursed by reimbursement after the recipient submits a completed expense report and a copy of expenses to the Foundation's program director.
- 5. A Grant Impact Report Form will be required to be completed and turned into the program director within 30 days after the workshop.
