- [ ] **Awards & Recognition Committee.** To review, evaluate and monitor existing recognition programs in relation to honoring credit union achievements, and work with League staff to facilitate the judging of Cornerstone (Hall of Fame, Professional of the Year, Volunteer of the Year, and Small Credit Union Achiever's Award) and National (Dora Maxwell, Louise Herring, Desjardins Youth and Desjardins Adult) award categories.
- [ ] **International Relationships Committee.** To provide leadership, education and plans for Cornerstone credit unions to serve and assist in the World-Wide Credit Union System:
  - ❖ In relation to Immigrant outreach, assist with identifying, developing and supporting initiatives and programs beneficial to Cornerstone credit unions in effectively serving their underserved and unbanked Immigrant communities.
  - ❖ In partnership with the World Council of Credit Unions, collaborate with League staff and credit unions to explore International cooperative engagement opportunities and interactions.
- [ ] **Governmental Affairs Committee.** To make recommendations to the League board regarding legislative agendas based on input from each state governmental affairs subcommittee. Further, work with the League advocacy team to provide input to Credit Union National Association on federal legislative issues.
- [ ] **State Governmental Affairs Subcommittees. Committee members serve on the subcommittee for their CU's state.** To make recommendations to the Cornerstone Governmental Affairs Committee regarding legislative agendas based on analysis of both current and proposed state regulations and laws impacting credit unions; to consult with the league and association management on state legislative and state regulatory issues.

- [ ] **Leadership Development Committee.** To review and enhance League initiatives focused on professional and leadership development.

Additionally, assist in the development, communication and enhancement of League initiatives and activities that enrich the credit union movement through credit union participation and heightened member engagement
- [ ] **Small Credit Union Committee.** To empower small credit unions to remain vital and healthy, foster communication between the League, chapters, and all credit unions; to provide a forum for the exchange and discussion of ideas and best practices in all realms of the credit union movement; and to serve as leaders to provide comprehensive resources and encourage affiliation with and support for the credit union system.
- [ ] **Regulatory Engagement Committee.** To study federal regulatory proposals and provide direction for regulatory comment letters, and to advise the League board and staff regarding regulatory proposals and regulatory relief efforts.
- [ ] **TCCUL: Texas Cornerstone Credit Union League PAC.** To promote the credit union business in Texas by raising funds to make campaign contributions to those seeking election or re-election to political offices, without regard to party affiliation.

- [ ] **ARCUPAC: Arkansas Credit Union PAC**. To promote the credit union business in Arkansas by raising funds to make campaign contributions to those seeking election or re-election to political offices, without regard to party affiliation.
