

Gary D. Parker Legacy Scholarship Application

Eligibility & Instructions for Submission

The Cornerstone Lending and Collections Council is offering Southwest Lending and Collections Conference YP attendees the opportunity to apply for the Gary D. Parker Legacy Scholarship, which covers the conference registration fee and a hotel room for three nights during the conference at no cost. Only one scholarship will be awarded. Applicants must be an employee of an Arkansas, Oklahoma, or Texas credit union and age 40 or younger.

About Gary Parker's Legacy

Gary Parker started his credit union career in 1974. He was a founding member of the Lending & Collections Council, for which he helped organize 18 conferences and many workshops. He lives and breathes the credit union philosophy of "people helping people" and has always been a mentor to many young credit union professionals.

1. Complete the scholarship application. Incomplete applications will **NOT** be accepted.
2. President/CEO of the credit union or organization must co-sign the scholarship application.

Process

1. The Cornerstone Lending and Collections Executive Committee will review all scholarship applications and select only one recipient.
2. Application selection will be personally communicated with applicants by the Cornerstone Lending and Collections Executive Committee no later than August 31, 2022, followed by a formal letter.
3. Recipient must be able to attend the 2022 Southwest Lending and Collections Conference, October 18-21, 2022.
4. Scholarship funds will go directly to pay the registration fee and the nightly hotel rate.
